- 2) Any Photo ID proof (Aadhar Card / Driving License, Pan Card, Pass port)
- 3) Copy of downloaded AIAPGET-2018 result.
- 4) Nationality certificate / valid passport / Domicile certificate or School Leaving Certificate of SSC / HSC indicating the Nationality of the candidate as "Indian".
- 5) Certificate of Age (SSC passing Certificate/Valid Passport)
- 6) First, Second, third & Final B.H.M.S., Statement of Marks.
- 7) B.H.M.S., Degree / Passing Certificate.

- 8) Internship Completion Certificate from University or the Head of the Institution.
- 9) Registration Certificate (MCH) / Proof of Application for Registration.
- 10) Medical Fitness Certificate.
- 11) Caste Certificate, Caste Validity Certificate, Non Creamy Layer Certificate (if applicable)
- 12) **Applicant belongs to Jain Minority:** (a) (i) School leaving certificate stating that the Candidate belongs to Jain religion and / or
(ii) Certificate from Religious place (Jain Temple) that the candidate belongs to Jain religion.
(b) Affidavit stating that He / She belongs to Jain Minority.
- 13) **Applicant belongs to Gujrathi Minority:** (a) (i) School leaving certificate stating that the mother tongue of Candidate is Gujrathi and / or
